UK Ministry of Defence

DIT first supported INNOVO on investment raising when it set up the INNOVO Joint Venture with the Ministry of Defence. INNOVO recruited Admiral Sir Trevor Soar, former Commander-in-Chief of the Royal Navy, as Chair of the JV and Luke van Beek CBE as CEO. The INNOVO JV with MOD is now working on a programme to decarbonise MOD buildings in conjunction with another INNOVO Joint Venture with GE.

SUPPORT BY KWASI KWARTENG AND COP26 UNIT

Following direct discussions with Government Ministers including Kwasi Kwarteng, BEIS submitted INNOVO to the Head of the COP26 Unit and we are regularly reporting our progress towards profitable Net Zero.

DIT is taking a leading role in the UK's efforts to tackle climate change, working across government to support the COP26 conference in Glasgow, and supporting the government's Net Zero commitments.


Ongoing Capital Raise: \$ Hundred+ Billion


Ongoing Liquidity: Internal Equity Market + Listing

An INNOVO ESG Exchange Traded Fund (ETF) is to be listed on the London Stock Exchange within 6 months. It will invest in INNOVO Innovation as a source of capital and offer exits.
